Rebecca,

I understand the rationale to getting started based on a couple of things...first, the concept of Hanwell means it would need to happen anyway, and, second, it will be triggered for study in May. In the next day or two, you will see two reports that I made on effective use of schools and sustainability studies be posted publically on our website and it will provide more context.

The process begins tonight with the motion and I expect it to last into early May. There will be much communication along the way, including a letter that will go home tomorrow to parents. We keep an active website as well. The PSSC can – and should – be engaged in the process. The letter will describe more.

We have exemptions for this year but the council felt that whereas this eventually needed to happen, perhaps it is best to start it now. I should note that our approach has always been to focus on “studying the school” and not to focus on “closing the school”. The result could be a) status quo, b) recommend to the Minister an investment in the school and c) recommend to the Minister a school closure. If the result is (c), then there will need to be a distinction if it is school closure for 2017-18 or if it is school closure based on the approval of Hanwell being built. That all comes out as a part of the study. So when I say a focus on “studying the school”, you won’t see me presenting to DEC in an effort to “convince” them to close the school. I will provide data and information about the school...I try to do so in a very neutral way. We have experienced some studies where it is respectful and focused on “the study” but we have also seen some studies where stakeholders get very defensive and take a disrespectful approach. We know the meetings (there will be three of them) can be emotional.

To answer your second question, I gained from the conversations that it was voted down last time because they wanted some additional information that aligned with the report I gave tonight...it was a timing issue.

Hi David,

In advance of the study and our meeting, our PSSC has been reading policy 409 and came across a few sections that were confusing to us. Unless I am mistaken, one of the possible outcomes of the study is recommending closure for September (the 2017/2018 year). However, certain elements of policy 409 seem to contradict that being a possible outcome.

After several of us have read this, we are unsure why you were able to trigger a study now, for decision in May/June, when the standard approach is to trigger it in May (allowing a full year for the process). And outside of that, if we are reading it correctly, if the intent to study notice is provided in May to the Minister, then it reads as though you would have to provide the recommendations from the study by the following Jan. 31 (today). Since we were not triggered for a study in May, and the recommendations will come after January, doesn't that go against the requirements stated below in 409?

Could you please help clarify if we are reading this wrong, or missing another area of the policy?

6.6.2 Any recommendation as a result of a triggered sustainability study must be submitted to the Minister no later than January 31st of the year following the DEC's notice to the Minister of its intent to initiate the study, as per section 6.1 and 6.4.2.

6.1.1 Each school district must prepare a district multi-year school infrastructure proposal, approved by the DEC, for submission to the Minister. The proposal will comprise five years and must be updated annually by May 31st.

6.1.2 The district multi-year school infrastructure proposal must include the following, as a minimum: b) a list of schools that will be subject to a triggered sustainability study;

Thanks for pointing out the document error. I had used a former McAdam copy as a template. Actually, Angela caught this error for me before it was sent to parents and we switched it,

but I must have forgotten to switch it with our Director who updates the website.

We are pulling together the presentation early this week so that it is ready for Thursday. I won't be able to give an indication of the possibility of closure as it is only a presentation of facts. The DEC will use all of the information from this meeting and the next meeting to help base their decision. They will also consider the reports that are built. The timeline may be a factor that the DEC considers in all of this. If they vote closure, then they will need to distinguish what they mean...do they mean closure for Sept-17, do they mean closure for Sept-18 or do they mean closure based on Hanwell. 2. We would like it to be clearly confirmed for us what the possibility of closure actually looks like during Thursday's meeting. After attending the DEC meeting I have to say I am confused. It seemed like members were discussing closing contingent on the opening of the Hanwell school and not for September 2017 as a possibility.

If September 2017 is still a possibility we have serious concerns over this given that kindergarteners will already have attended their orientations as KCS and that the minister's decision may not come until July when school is already out and there is no chance for anyone to properly prepared their children as a result since schools do not re-open until the last two weeks of August and at that point an administrator would need to get up to speed still before they could even prepare children.

We are fine going through the study, our concern with the timelines is and always has been the potential for a closure in September as it is not in the best interest of our children. We would really like to have that clarified for us.
